1 Introduction

General Music Teacher is a 2-year MMus programme where students can continue the development of their knowledge, skills, and qualifications as music teachers and musicians. Taking their musicianship as a starting point, students immerse themselves in electives and the main study area. Students can choose a classical or jazz/pop main instrument (40 ECTS).

Students can apply to substitute a direction subject for their main instrument. See Main study area below.

From the elective catalogue, students can choose Main instrument pedagogics and other direction subjects.

Depending on the subject, electives and projects (35 ECTS in total) focus on the student's skills and/or pedagogical qualifications.

The programme forms the basis of the student's choices during his/her future career as a music teacher and musician.

Programme structure

The programme focuses on the student's development as a teacher, musician, and artist. As a consequence, emphasis is placed on the main instrument and on subjects that support and develop a creative and reflected approach to teaching and creating music.

The programme is the most diverse music teacher MMus degree offered at the Academy. As such, it also offers the highest degree of independence and choice for the student.

Artistic entrepreneurship, which is concluded after the 2nd semester, provides the student with relevant tools for administering his/her artistic and pedagogical ambitions through e.g. self-management and entrepreneurial skills.

The programme concludes with a student-defined Master's project based on student interests and needs. The project constitutes the student's specialisation in music.

The programme subjects are divided into the following fields:

- Main study area: subjects where the student is a performer, creator, and teacher, as well as subjects and projects that support these aspects
- Electives: subjects and projects supporting work as a performer, creator, or teacher
- Artistic entrepreneurship: subjects and projects where the student explores the role as entrepreneur and manager of dynamic processes, and in addition develops his/her career management tools
- Master's project: in addition to work on the project itself and attendant guidance, this includes tuition on subjects that prepare the student for the final project work

2.1 Main study area

2.1.1 Main instrument/direction subject and theory of music pedagogy

The following main subjects are available:

- Jazz/pop or classical main instrument
- Jazz/pop choir conducting
- Classical choir conducting
- o Ensemble teaching practice
- o Orchestra and ensemble teaching practice
- o Elementary music pedagogy, adults and children

Objective

As students can choose from a number of main subjects, the objectives are divided into three groups. One applies to all main subjects, and two apply to main instruments or direction subjects, respectively.

The following objectives apply to all General Music Teacher main subjects

Upon completion of the course, the student:

- Possesses specialist knowledge of artistic and technical practice, repertoire, methods, and theory
- Possesses specialist knowledge of relevant pedagogical, didactic, and psychological theories, concepts, and methods
- Understands and is able to reflect on practice and choice of methods in relation to his/her own artistic practice as well as in relation to tuition and communication courses
- Has mastered artistic and technical skills and forms of expression
- Is able to independently argue and assume responsibility for his/her own learning needs, specialisation options, and potential for creative development, and prioritise and structure his/her time and work efforts
- Is able to act professionally as regards responsibilities and ethics

The following objectives apply to

- Jazz/pop choir conducting
- o Classical choir conducting
- o Ensemble teaching practice
- o Orchestra and ensemble teaching practice
- o Elementary music pedagogy, adults and children





Upon completion of the course, the student:

- Can take a critical and analytical approach to music education practice
- Commands critical and analytical approaches to musical practice
- Is able to assess and choose from artistic forms of expression and make qualified and reflected artistic and pedagogical choices
- Is able to work with artistic communication and discuss music education, music business, and business-related problems with peers as well as nonspecialists
- Is able to manage complex creative challenges in the development and realisation of his/her musicianship in a globalised world
- Can commence and direct musical ensemble teaching and interdisciplinary cooperation in the musician, teacher, and communicator roles

The following objectives apply to

Jazz/pop or classical main instrument

Upon completion of the course, the student:

- Can take a critical and analytical approach to music
- Commands critical and analytical approaches to music performance practice
- Is able to assess and choose from artistic forms of expression and make qualified and reflected artistic and pedagogical choices
- Is capable of effortless expression on his/her instrument or when singing
- Possesses knowledge of instrument/vocal theory and method
- Is able to work with artistic communication and discuss music education, music business, and business-related problems with peers as well as nonspecialists

Content

Tuition involves further development of the student's personal artistic expression and musical/technical ability, as well as a reflection on music pedagogical practice, development and research work in the field of music pedagogy, and related concepts, issues, and themes.

Tuition may for example include the following:

- soloist skills
- improvisation
- composition
- artistic development activities
- aspects of ensemble playing
- accompaniment
- rhythm and timing
- phrasing, interpretation
- timbre, instrument/vocal technique





- learning by ear
- imitation
- transcription
- transposition

Tuition and work formats

Possible tuition and work formats:

- One-to-one tuition, class tuition, group work, guidance
- Work in band contexts
- Participation in Academy projects is an important part of the student's main study area activities

Projects can be initiated by the Academy and by the student.

For wind players, participation in a big band is mandatory. Mandatory participation for wind players may not exceed two big band projects per semester, equivalent to 3 ECTS. Other students can apply for participation or be appointed by the big band leader. A big band project normally corresponds to 1.5 ECTS. By participating in at least 3 big band projects, students can receive merit for a 5 ECTS elective, for example. Students must apply for merit to the head of studies.

Part of the tuition takes the form of preparation for and evaluation of student performances at internal and external concerts. The student is required to act as band leader and assume artistic responsibility for at least one concert annually. Participation in all of these work formats is part of the ECTS workload for the main study area.

Semesters

1st to 4th semester

Scope

50 ECTS

Music pedagogical theory: 10 ECTS, to be documented after the 2nd semester Main instrument: 40 ECTS, to be documented after the 4th semester

Evaluation and examination regulations

After the 2nd semester: music pedagogical theory examination

Examination content

At the examination, a written assignment on a teacher approved subject is handed in. Students may work in groups of 1-4.

Scope:

1-2 students: 10 to 12 pages 3-4 students: 15 to 18 pages

The assignment must be handed in by the date communicated by the Study



Administration.

Examination format

The oral examination is individual and starts with an independent elaboration by the student lasting for a maximum of 10 minutes. This is followed by an interview of approx. 20 minutes on the subject.

Total duration including deliberation: 45 minutes.

Marking and evaluation

Internal marking. Grade.

The assessment must reflect to what extent the objectives have been achieved.

Objective:

- Possesses specialist knowledge of relevant pedagogical, didactic, and psychological theories, concepts, and methods
- Understands and is able to reflect on practice and choice of methods in relation to teaching and communication courses
- Can take a critical and analytical approach to music education practice
- Is able to assess and choose from artistic forms of expression and make qualified and reflected pedagogical choices
- Is able to work with artistic communication and discuss music pedagogical problems with peers as well as non-specialists
- Is able to manage complex pedagogical processes in multicultural contexts
- Can commence and direct musical ensemble teaching and interdisciplinary cooperation in the musician, teacher, and communicator roles
- Is able to act professionally as regards responsibilities and ethics

After the 4th semester: student skill examination

Examination content

At a concert, the student performs a programme chosen by the student and featuring the student in an important role.

Examination format

Concert. Duration: 30 minutes.

Total duration including deliberation: 60 minutes.

Marking and evaluation

External marking. Grade.

The assessment must reflect to what extent the objectives have been achieved.

2.2 Artistic entrepreneurship

Objective

Upon completion of the course, the student:

- Possesses specialist knowledge of the music business and culture in an international context
- Understands and is able to reflect on professional practice and the complex relations between music industry players
- Is able to assess challenges and issues in relation to his/her career, create relevant solution models, and make informed and reflected career decisions
- Is able to communicate his/her own artistic profile and discuss vocational issues in relation to peers, audiences, and media
- Can commence and lead independently in various professional contexts, participate in cross-disciplinary artistic collaboration, and assume artistic citizenship
- Is able to independently assume responsibility for his/her own potential for creative development in a professional career context

Content

The student's work with artistic entrepreneurship is based on the student's own projects and practice. Tuition seeks to support this and may include the following:

- Self-management
- Individual research
- Development of ideas
- Project design and management
- Communication
- Financials
- Music and issues in society
- Business plan
- Sales
- Marketing
- Partnerships and cooperation with other music industry players
- Cross-disciplinary artistic collaboration
- Artistic citizenship

The 1st semester is concluded with an assignment. This can be either a short written assignment (3 to 5 pages) or an oral presentation during class.

2nd semester: examination assignment

Tuition and work formats

Class tuition, seminars, and individual guidance



Scope

10 ECTS

Semesters

1st to 2nd semester

Evaluation and examination regulations

After the 2nd semester: examination

Examination format

Oral examination (25 minutes) based on the examination assignment. Scope: 8-10 pages excluding annexes

The examination assignment must provide a perspective on central issues pertaining to the subject with relevant literature (theory and/or method).

During the oral examination, the student relates theory to his/her own professional practice and uses this as a starting point for a reflection on his/her professional and personal development.

The assignment must be handed in by the date communicated by the Study Administration.

Total duration including deliberation: 40 minutes

Marking and evaluation

Internal marking. Grade.

The assessment must reflect to what extent the objectives of the course have been achieved.



2.3 Electives

Every year, the Academy offers a number of pedagogical and artistic electives of 5 ECTS or 10 ECTS. The ECTS workload is stated in the description of each elective.

A total of 35 ECTS is to be earned from electives.

On MMus General Music Teacher, pedagogical electives account for at least 20 ECTS.

Content and objectives

The content and related objectives of the electives are stated in the descriptions of each elective.

Tuition and work formats

Electives are primarily executed as class tuition. Where relevant, however, other options are possible; this will be stated in the description of each elective.

Semesters and scope

1st semester – 10 ECTS 2nd semester – 10 ECTS 3rd semester – 10 ECTS 4th semester – 5 ECTS

Evaluation and examination regulations

Certificate with the evaluation Approved/Not approved. This certifies that the objectives have been achieved at a level at least corresponding to a Pass, and that current attendance rules have been followed.

Some pedagogical electives are evaluated using internal censorship. When relevant, this is stated in the elective catalogue.



2.4 Master's project

Objective

Upon completion of the course, the student:

- Possesses specialist knowledge of practice, methods, and theory within the chosen project area
- Understands and is able to reflect on his/her practice and choice of methods in relation to the project
- Has acquired mastery of relevant methods, tools, and forms of expression within the chosen project area
- Is able to identify project relevant knowledge and evaluate, create, and choose from project-related solution models
- Can communicate and discuss project ideas and results achieved verbally and in writing
- Is able to manage complex and creative challenges in relation to project work
- Is able to find relevant cooperation partners and act with integrity and professionalism in vocational and/or cross-disciplinary cooperation
- Is able to assume responsibility for his/her own learning needs and potential for development in relation to project work and draft and manage a realistic schedule

Content

The master's project builds upon (one or more of) the student's main study areas but may draw on cross-disciplinary approaches.

The student chooses and defines his/her own project. The project must include the following elements:

- 1) Work within one or more of the following areas
 - a) Composition/songwriting/arrangement
 - b) Professional artistic performance
 - c) Pedagogics/communication
 - d) Artistic entrepreneurship
- 2) Written assignment. Scope: 15-30 pages excluding annexes

The joint guidance classes for the master's project include tuition on assignment writing topics such as project formats, research methodology, interview technique, and literature searches. Tuition may be scheduled together with Artistic entrepreneurship.

Tuition and work formats

The project is executed during the 3rd and 4th semesters.

Individual project guidance is provided.

In addition, the Master's project is prepared and supported in joint guidance classes.

Important dates

1 April, 2nd semester

The student submits the following to the project coordinator: a preliminary title and a brief description of one or more project ideas, and a prioritised application for a project



supervisor.



Early September, 3rd semester

Introductory meeting with the project coordinator

The student is introduced to the scope, form, and opportunities of the master's project and is prepared for creating the project description.

Study groups of 3-6 students are set up.

The groups convene at least three times during the project period.

1 November, 3rd semester

The project description is submitted for approval with the project coordinator.

This first project description must include the following:

- Title
- Objective
- Motivation (personal and general)
- A description of the product (the content itself and the result of the project)
- A description of the process:
 - o preparation (literature, music references, interviews, etc.)
 - o elements of the project process (for example, rehearsals, recordings, work with composition/songwriting, cooperation partners, etc.)
- Schedule

1 February, 4th semester

In consultation with the project supervisor, the student creates a final project description on which the rest of the work, and the evaluation of the project, are based. This project description is binding in relation to handing in the written project. The requirements of the descriptions are stated above.

15 April, 4th semester

The written assignment is handed in. Scope: 15-30 pages excluding annexes The assignment is handed in along with all other relevant material that the board of examiners must be familiar with before the examination.

Scope

25 ECTS

Evaluation and examination regulations

Examination format

A: Presentation (30 minutes)

Depending on the nature of the project, the presentation may for example take the following forms:

- A concert incorporating oral communication
- A teaching situation using a project-related approach
- A lecture/presentation of the project including documentation of the artistic/performative dimension in the form of a portfolio, CD/DVD recordings or similar

It is important that the presentation elaborates, or provides perspectives on, the content of the written assignment.



The repertoires of the examination concert and the artistic/performative dimension of the master's project may overlap.

B: Interview with the board of examiners (10 minutes) Deliberation and preparation of statement (20 minutes) Total duration including deliberation: 60 minutes

Marking and evaluation
External marking. Grade and a written statement.

The assessment must reflect to what extent the objectives have been achieved.
